**(vi) Institutional set-up for liquidity risk management**

Ultimate responsibility for liquidity risk management rests with the Board of Directors, which has established the Local Risk Committee and Asset and Liability Management Committee (ALCO) for the management of the Company's liquidity management requirements. The Company continues to prudently manage its asset liability management (ALM) with a strategy of raising long-term debts from various banks. The Company manages liquidity risk by continuously monitoring forecast and actual cash flows, and by matching the maturity profiles of financial assets and liabilities. This has enabled it to find liquidity always and at competitive rates. The Company continues to closely monitor liquidity in the market; and as a part of its Local Risk and ALCO strategy maintains a liquidity buffer to prudently manage liquidity risk.
