Hire Purchase

With a hire purchase agreement you know exactly what the payment will be each month. This helps keep budgeting simple. Flexible repayments can be agreed so that they match your cash flow requirements. Once the final instalment has been paid, ownership of the equipment transfers automatically to you.

Lease Agreements

A lease agreement lets you pay for equipment over a set period of time. Once you have identified the equipment you need and negotiated the purchase, we will pay the supplier and keep legal ownership of the equipment. You then lease the equipment from us over an agreed period of time - usually from five to seven years for tractors.

At the end of the agreed period, you have a number of options:

- 2) Sell the equipment as our agent and keep all the sales proceeds.
- 3) Trade it in as repayment against new equipment.

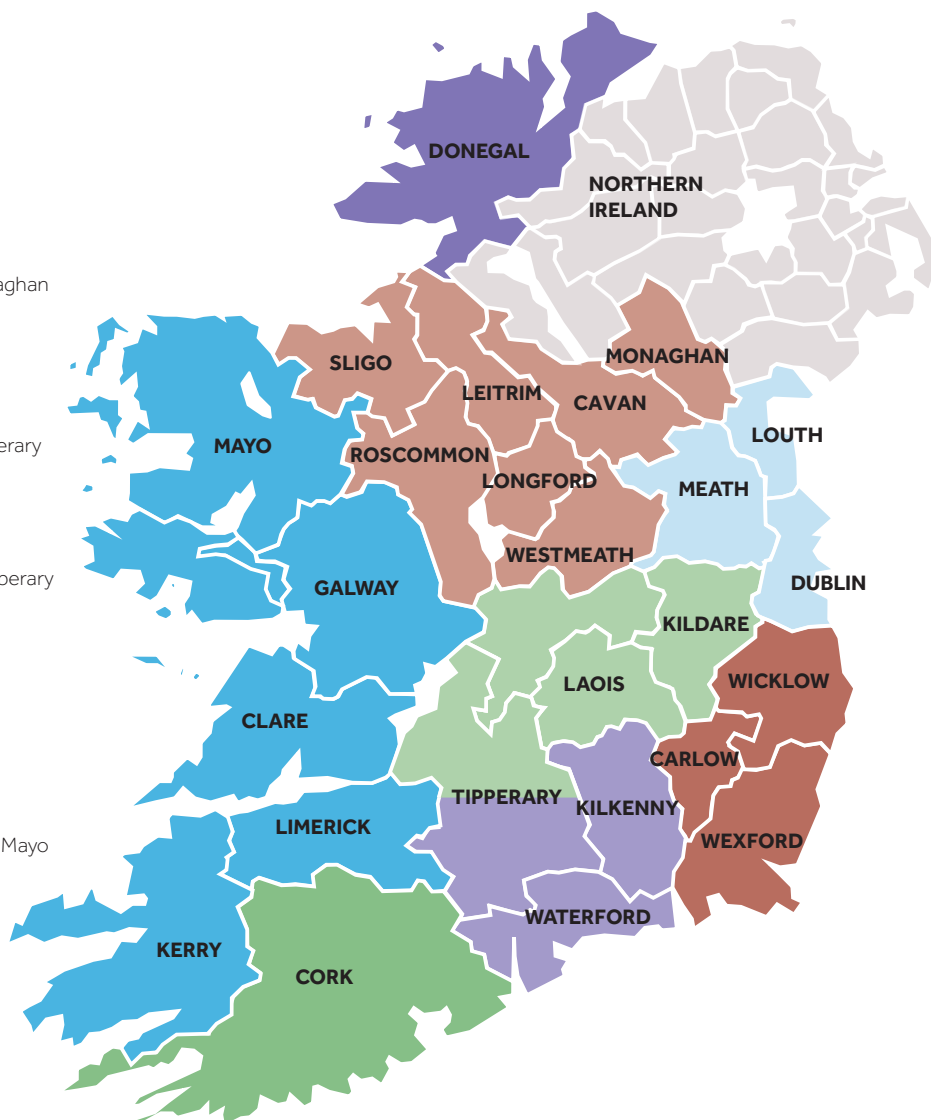

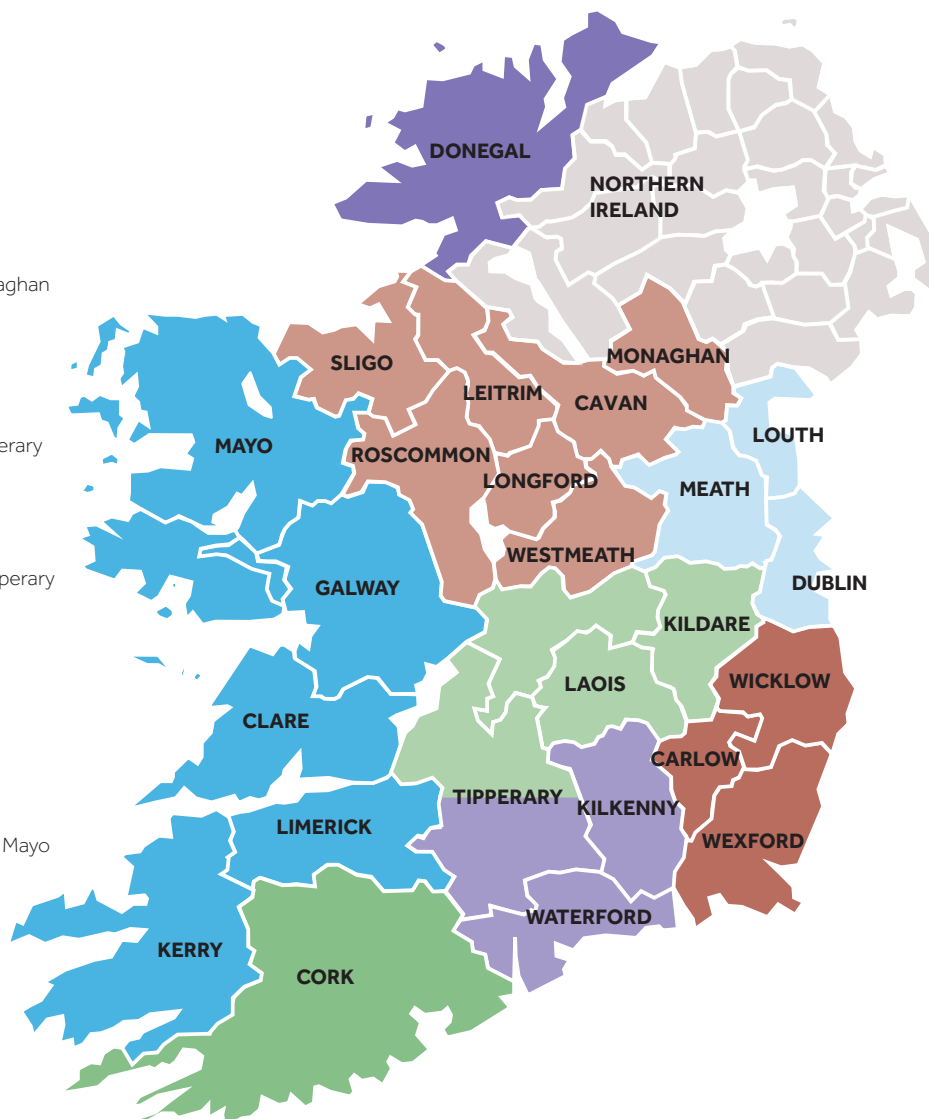
