U.S. PRIVACY STATEMENT

This Privacy Statement is intended to inform you about the information that our Controlled Affiliates in the U.S. may collect about you, how we use that information, and with whom that information may be shared. Who We Are

We are a global vendor finance company and part of the DLL Group and the Rabobank Group. We provide asset-based financial solutions in the Agriculture, Food, Healthcare, Clean Technology, Construction, Transportation, Industrial, Office Equipment, and Technology industries.

Categories of Personal Information We Collect

When you interact with us in person, over the phone, in writing, electronically, or through a third party or any of our global affiliates, we <u>may</u> collect a variety of information that we maintain in a manner that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with you ("**Personal Information**"). This Personal Information <u>may</u> belong to one of the following categories:

- Identifiers such as a real name, business name, alias, mailing address and physical address, unique personal identifier, online identifier, Internet Protocol address information, email address, account name, date of birth, government-issued (federal or state) identification and number, or other similar identifiers
- Characteristics of protected classifications under applicable law, such as gender, race, ethnicity, national origin, citizenship, marital status, or military status
- Professional or employment-related information, such as business entity information, professional affiliations, or employment history
- Education information, such as education history or degrees obtained
- Commercial information, such as business needs and operational information, records of personal property, products or services purchased, obtained, or considered, payment history, or other purchasing or consuming histories or tendencies
- Biometric information
- Geolocation data
- Internet or other electronic network activity information, such as browser type, operating system, browsing history, search history, user login and authentication data, and information regarding your interaction with a website, application, or advertisement
- Electronic, audio, visual, or similar information, such as records of calls to or from us
- Any other categories of personal information under applicable law, such as financial information, identity verification information, banking information, or credit information
- Inferences drawn from any of the categories listed above

Sources of Collected Personal Information

We <u>may</u> collect your Personal Information from the following sources:

- You or those authorized to provide your Personal Information on your behalf, including via your transactions with us or as collected through your browser or device when you visit our website or use our applications
- Third parties, including but not limited to, affiliates, joint venture partners, other related parties, manufacturers and vendors, dealers and distributors of goods or services you finance with us, business partners, credit bureaus, employee benefit providers, and suppliers who provide goods and services to us
- Public records
- From equipment you finance with us we take reasonable steps to destroy Personal Information from equipment you finance with us, though we may collect information about equipment usage if it cannot reasonably identify, relate to, describe, be capable of being associated with, or linked, directly or indirectly, to you or your household

When you visit our website or use our applications, we may automatically collect information using cookies, pixel tags, web beacons, and other similar or related technologies. Some of this information is not capable of identifying you but some information can be associated with you, your browser, or your device. We may have relationships with third-party advertising companies to help track and report on usage of our website and applications. These advertising companies may place cookies on your device to display targeted advertisements to you.

Use of Collected Personal Information

We may collect, use, process, or disclose your Personal Information for the following purposes:

- Performing services on your behalf, processing your requests, fulfilling our obligations to you, assessing your eligibility for our products and services, verifying your identity and information, completing transactions for which your information was collected, maintaining or servicing your accounts, providing customer service, and communicating with you, or providing other goods or services you requested or that are reasonably anticipated within the context of our ongoing business relationship with you
- Advertising or marketing additional products and services to you that are related to products and services you request or that are offered by us, our affiliates, or a nonaffiliated third party
- Administering promotions, surveys, pools, sweepstakes, and contests
- Providing employment benefits and other employment-related services
- Conducting audits, internal research, product quality, safety, and development, risk modeling, data analysis, demonstration purposes and other solely internal uses that are reasonably aligned with your expectations based on your relationship with us or the context in which you provided your information to us
- Debugging to identify and repair errors that impair existing intended functionality
- In connection with securitizations, syndications, or loan or lease participations
- Facilitating the sale, transfer, merger, reorganization, or other change to a business line or legal entity
- Detecting security incidents and protecting against malicious, deceptive, fraudulent, or illegal activity, and prosecuting those responsible for that activity
- Processing privacy rights requests

- Investigating fraud
- Handling current or prospective legal claims
- Complying with all local, state, federal, and international laws and other legal and regulatory requests and obligations

Disclosure of Collected Personal Information

We <u>may</u> share your Personal Information on a confidential basis with our affiliates, joint venture partners, other related parties, manufacturers and vendors, dealers and distributors, business partners, credit bureaus, employee benefit providers, suppliers, and other third parties for all of the purposes described above.

We may also disclose your Personal Information to third parties if it cannot reasonably identify, relate to, describe, be capable of being associated with, or linked, directly or indirectly, to you or your household.

We do not sell your Personal Information to third parties.

Cross-Border Transfers of Collected Personal Information

We do business in multiple locations throughout the U.S. We also have affiliates located in various countries throughout the world. Your Personal Information may be accessed, processed, and transferred to affiliates and other third parties in the U.S. and elsewhere in the world for the purposes described in this Privacy Statement.

Links to Third-Party Websites

We are not responsible for the privacy or security of any information you provide to a third-party website or the information practices used by any third-party website, including links to any third-party site from our website. The inclusion of a link to a third-party website on our website does not constitute any type of endorsement of the linked website by us.

Do Not Track Disclosures
